

# Investment Update

## What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 35 - 44 has performed and what fees were charged. The document will help you to compare the investment option with other investment options and funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this investment option

This life cycle investment stage invests 30% in the Lifestages Income Fund and 70% in the Lifestages High Growth Fund, which is regarded as providing appropriate levels of risk and return for a person aged 35-44.

## What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 35 - 44:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

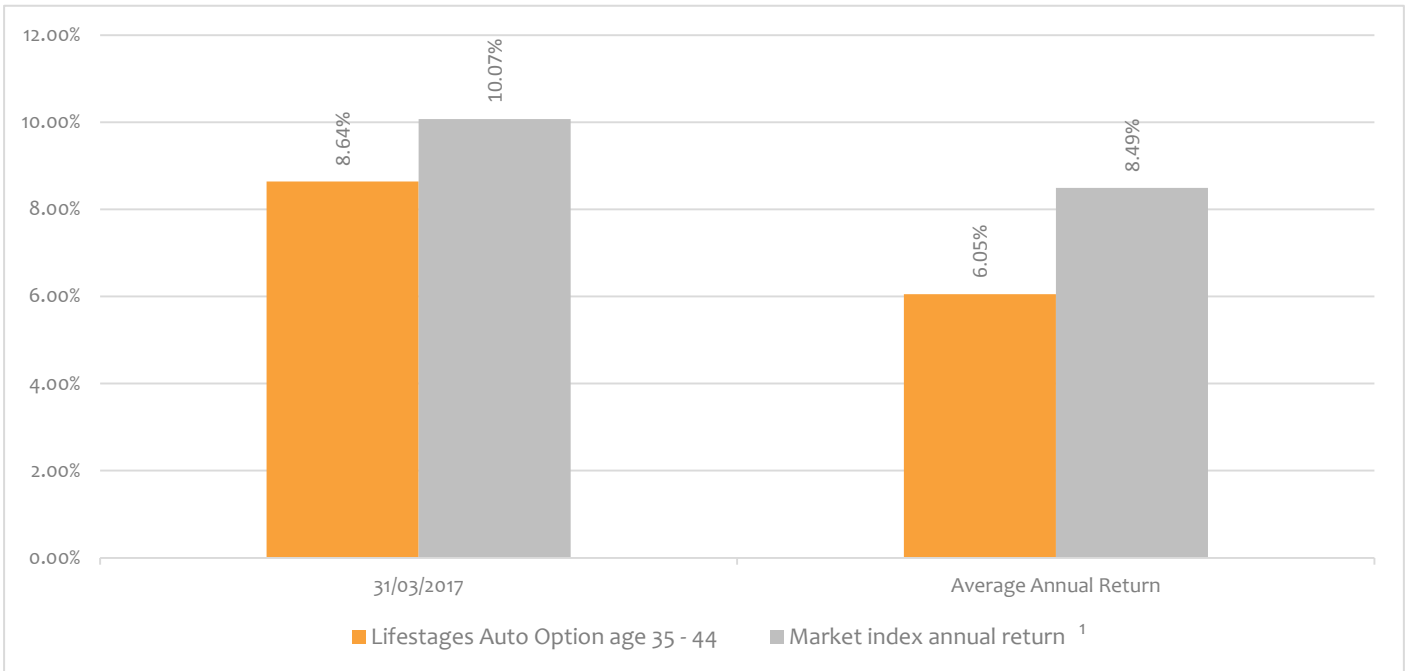
## How has the investment option performed?

### Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 31 March 2017.

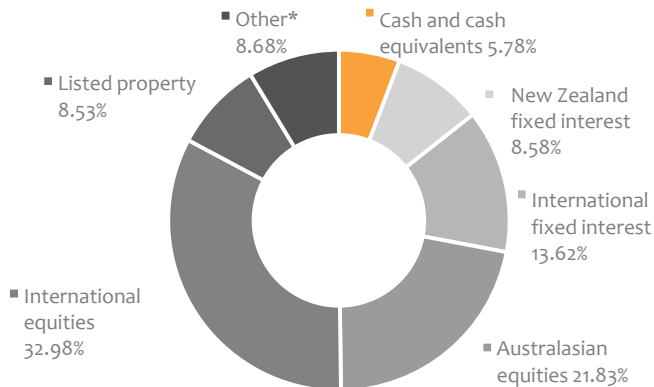
### Example of how this applies to an investor

Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$970 (that is 9.70% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total return after tax of \$840.00 for the year.

### Currency hedging

Currency hedging can apply to some of the asset classes this investment option invests in. The level of currency hedging for foreign assets is managed to a target of 100% for international fixed interest, 50% for international equities and 0% for the other foreign assets. This may change over time depending on the Manager's view of the relative strength (or weakness) of the New Zealand dollar.

## Notes

- Note that market indices reflect no deduction for charges and tax.
- As the investment option started on 14 October 2015, annual fund charges of the investment option for the year to 31 March 2016 are not available. The charges reflect the fees disclosed in the PDS instead.
- This covers expenses incurred in running the fund invested in (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the Lifestages fund invested in.
- The investment option invests 30% in the Lifestages Income Fund and 70% in the Lifestages High Growth Fund. The actual investment mix, target investment mix, top 10 investments and currency hedging all reflect the assets invested proportionally in these Lifestages Funds.
