## What is the purpose of this update?

This document tells you how the Lifestages Corporate Bond Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to provide a core and low risk exposure to New Zealand fixed interest debt securities through investments consisting of a broad spread of government and nongovernment securities primarily of investment grade quality.

## What are the risks of investing?

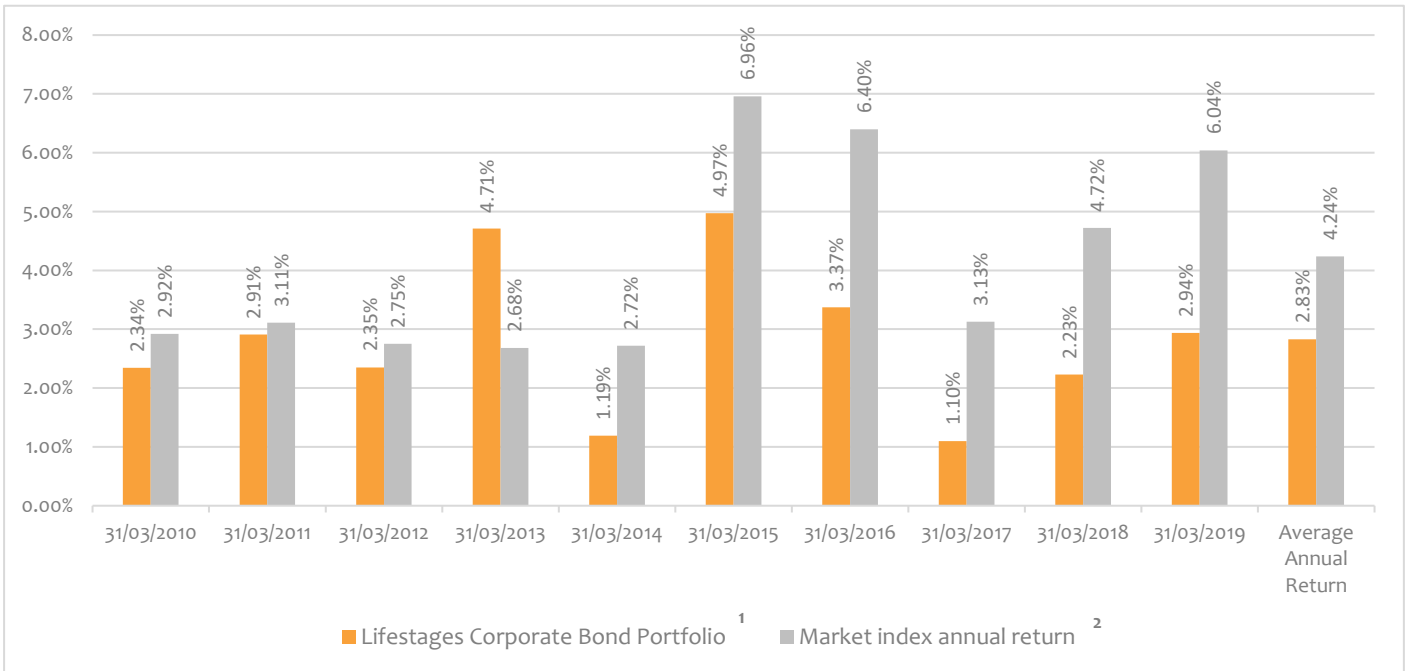
## How has the fund performed?

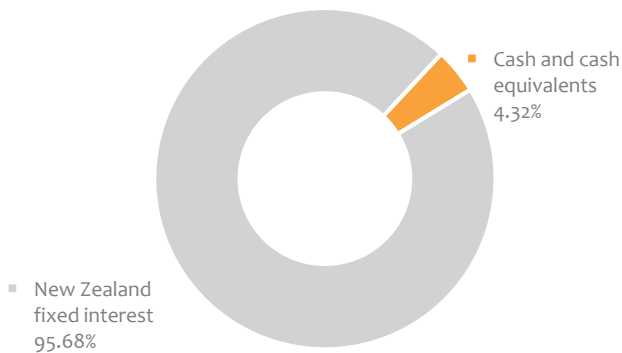
### Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$477 (that is 4.77% of her initial \$10,000). This gives Hayley a total return after tax of \$343.00 for the year.

- <sup>1</sup> Prior to 31 October 2011 the Corporate Bond Portfolio was known as the Mortgage Distributing Portfolio. Therefore the returns disclosed up to 31 October 2011 reflect those of the Mortgage Distributing Portfolio.
- <sup>2</sup> Note that market indices reflect no deduction for charges and tax.
- <sup>3</sup> Includes GST.
- <sup>4</sup> This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
