What is the purpose of this update?

This document tells you how the Lifestages World Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investment primarily in a broad spread of international equites. The fund offers a multi-manager approach to equity investing.

Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$981 (that is 9.81% of her initial \$10,000). This gives Hayley a total return after tax of \$894.00 for the year.

Currency hedging

As at 31 December 2020 the fund has an exposure to foreign currency assets of 97.71%, of which 50.58% was hedged back to NZD. This means the fund's foreign currency exposure is 47.13%.
