## What is the purpose of this update?

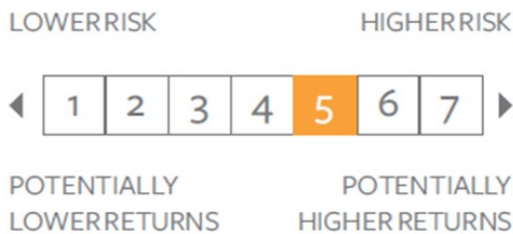
## Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investing primarily in a broad spread of New Zealand and Australian equities. The fund offers a multimanager approach to equity investing.

## What are the risks of investing?

Risk indicator for the Lifestages Australasian Equity Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

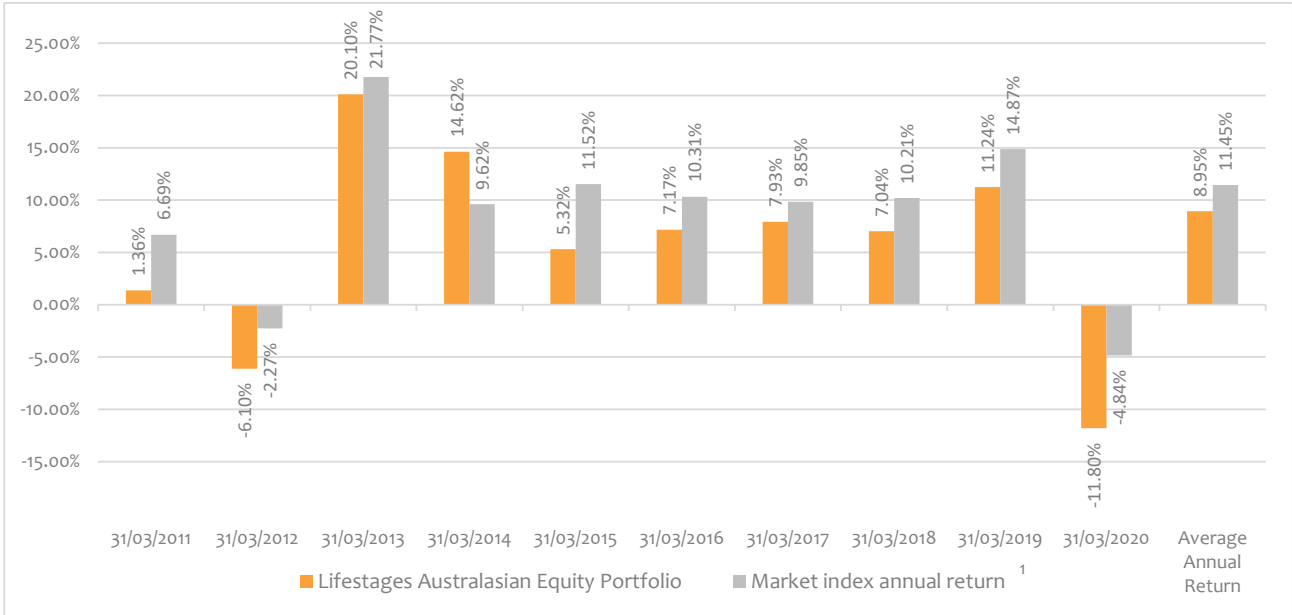
## How has the fund performed?

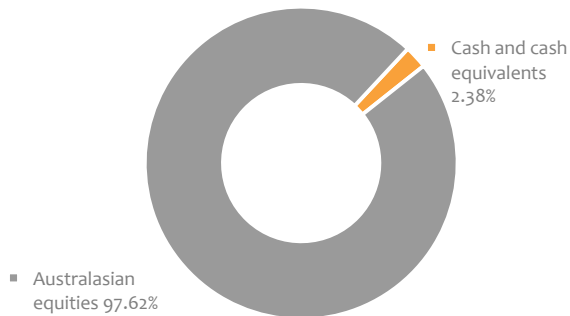
### Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$786 (that is 7.86% of her initial \$10,000). This gives Hayley a total return after tax of \$744.00 for the year.

### Currency hedging

As at 31 December 2020 the fund has an exposure to foreign currency assets of 32.61%, of which 0.00% was hedged back to NZD. This means the fund's foreign currency exposure is 32.61%.
