What is the purpose of this update?

This document tells you how the Lifestages World Bond Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide investors with a broadly diversified portfolio of international investment grade income securities. The fund offers a multi-manager approach to fixed interest investing.

What are the risks of investing?

Risk indicator for the Lifestages World Bond Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

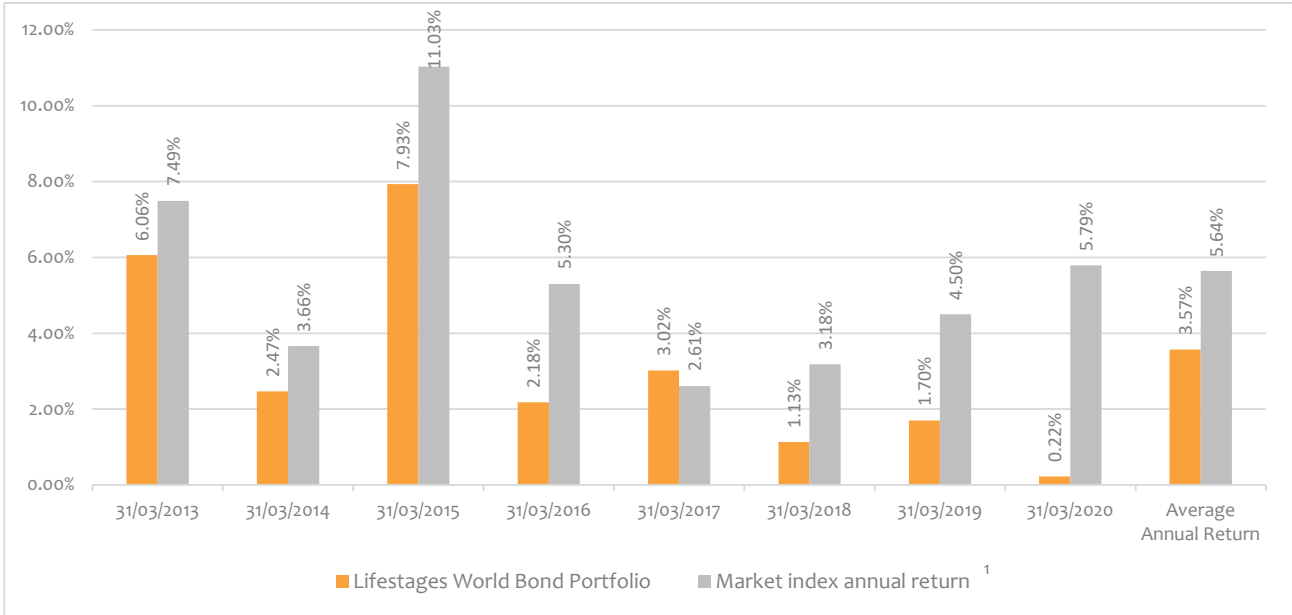
How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2020.

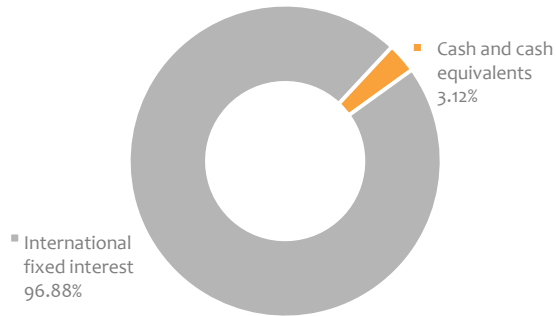
Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$382 (that is 3.82% of her initial \$10,000). This gives Hayley a total return after tax of \$249.00 for the year.

Currency hedging

As at 31 December 2020 the fund has an exposure to foreign currency assets of 96.88%, of which 96.88% was hedged back to NZD. This means the fund's foreign currency exposure is 0.00%.
