
Description of this fund

The fund aims to provide a core and low risk exposure to New Zealand fixed interest debt securities through investments consisting of a broad spread of government and nongovernment securities primarily of investment grade quality.




Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$428 (that is 4.28% of her initial \$10,000). This gives Hayley a total return after tax of \$308.00 for the year.
