What is the purpose of this update?

This document tells you how the Lifestages Corporate Bond Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide a core and low risk exposure to New Zealand fixed interest debt securities through investments consisting of a broad spread of government and nongovernment securities primarily of investment grade quality.




Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$154 (that is - 1.54% of her initial \$10,000). This gives Hayley a total loss after tax of -\$111.00 for the year.
