What is the purpose of this update?

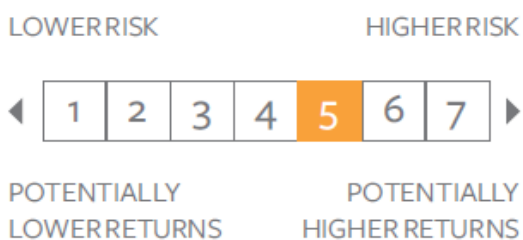
Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investment primarily in a broad spread of international equities. The fund offers a multi-manager approach to equity investing.

What are the risks of investing?

Risk indicator for the Lifestages World Equity Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

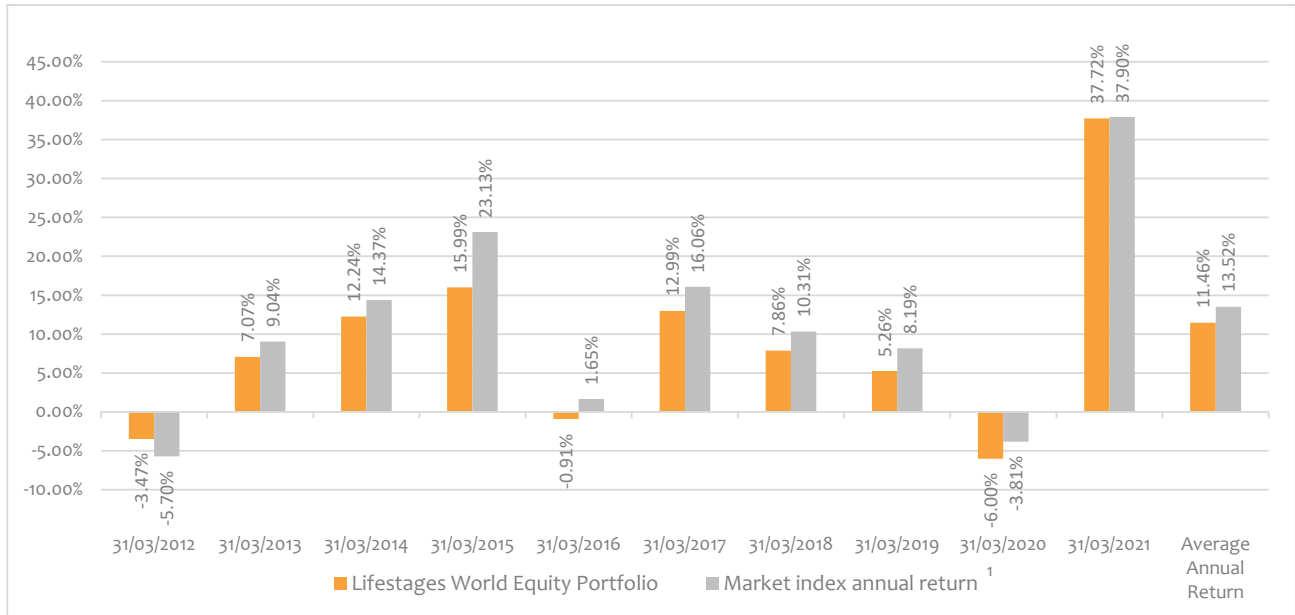
How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$2,351 (that is 23.51% of her initial \$10,000). This gives Hayley a total return after tax of \$2,261.00 for the year.

The top 10 investments make up 101.37% of the net asset value of the fund.

Currency hedging

As at 31 December 2021 the fund has an exposure to foreign currency assets of 90.53%, of which 50.10% was hedged back to NZD. This means the fund's foreign currency exposure is 40.43%. These fees are deducted from, and reflected in the unit price of the fund.
