What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 45 -54 has performed and what fees were charged. The document will help you to compare the investment option with other investment options and funds. 
Description of this fund

This life cycle investment stage invests 60% in the Lifestages High Growth Fund and 40% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 45-54.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 45 - 54:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the investment option performed?



Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$863 (that is -8.63% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$943.53 for the year.

Currency hedging

As at 30 June 2022 the investment option has an exposure to foreign currency assets of 66.53%, of which 34.80% was hedged back to NZD. This means the investment option's foreign currency exposure is 31.73%.
