What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 55 - 64 has performed and what fees were charged. 
Description of this fund

This life cycle investment stage invests 40% in the Lifestages High Growth Fund and 60% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 55-64.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 55 - 64:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$773 (that is -7.73% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$837.09 for the year.

The top 10 investments make up 61.92% of the net asset value of the investment option.

Currency hedging

As at 30 June 2022 the investment option has an exposure to foreign currency assets of 59.15%, of which 37.99% was hedged back to NZD. This means the investment option's foreign currency exposure is 21.16%. - ¹ Note that market indices reflect no deduction for charges and tax.
