

# Fund Update

## Lifestages Investment Funds Lifestages World Bond Portfolio for the quarter ended 30 September 2022

This fund update was first made publicly available 31 October 2022

### What is the purpose of this update?

This document tells you how the Lifestages World Bond Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

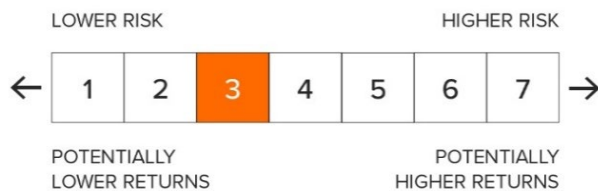
### Description of this fund

The fund aims to provide investors with a broadly diversified portfolio of international investment grade income securities. The fund offers a multi-manager approach to fixed interest investing.

### What are the risks of investing?

Risk indicator for the Lifestages World Bond Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

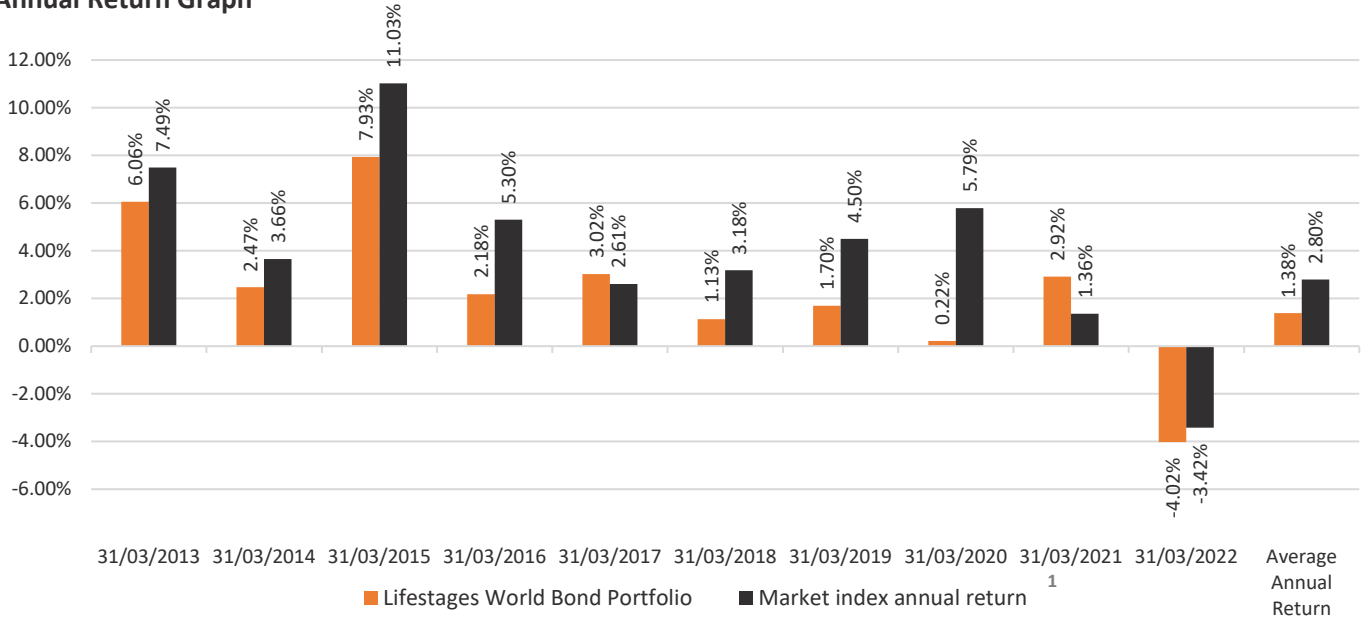
### How has the fund performed?

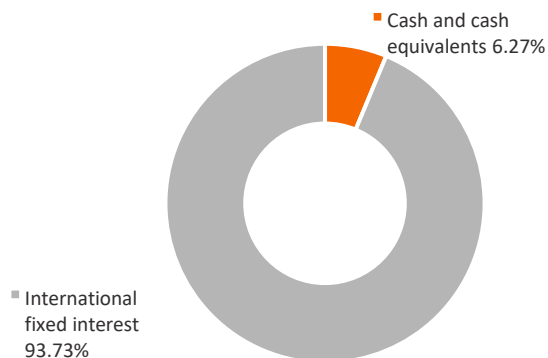
## Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,103 (that is -11.03% of her initial \$10,000). This gives Hayley a total loss after tax of -\$851.00 for the year.

## Currency hedging

As at 30 September 2022 the fund has an exposure to foreign currency assets of 93.73%, of which 93.73% was hedged back to NZD. This means the fund's foreign currency exposure is 0.00%. <sup>3</sup> This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
