What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 55 - 59 has performed and what fees were charged. The document will help you to compare the investment option with other investment options and funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

This life cycle investment stage invests 60% in the Lifestages High Growth Fund and 40% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 55-59.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 55 - 59:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the investment option performed?



Therefore the fee information contained in this document reflects the disclosures that would have applied had the option been in existence as at 31 March 2022. From 1 December 2022, the \$24 annual Member fee was removed. The total fund charges are expected to be 1.03% per annum from 1 December 2022.

Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,189 (that is -11.89% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$1,282.68 for the year.

Currency hedging

As at 31 December 2022 the investment option has an exposure to foreign currency assets of 71.03%, of which 42.04% was hedged back to NZD. This means the investment option's foreign currency exposure is 28.99%. - ¹ Note that market indices reflect no deduction for charges and tax.
- ² This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
- 3 The investment option invests 60% in the Lifestages High Growth Fund and 40% in the Lifestages Income Fund. The actual investment mix, target investment mix, top 10 investments and currency hedging all reflect the assets invested proportionally in these Lifestages Funds.
- * This investment option was established in December 2022. Under the FMCA 2013 the historical returns contained in this document must reflect the disclosures that would have applied had the option been in existence when Lifestages Auto was established in 2015.
