
## Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investing primarily in a broad spread of New Zealand and Australian equities. The fund offers a multimanager approach to equity investing.

# What are the risks of investing?

Risk indicator for the Lifestages Australasian Equity Portfolio:

# How has the fund performed?

## Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$310 (that is -3.10% of her initial \$10,000). This gives Hayley a total loss after tax of -\$381.00 for the year.


