What is the purpose of this update?

This document tells you how the Lifestages High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide investors with capital growth over the long-term, by investing primarily in a broad spread of New Zealand and international growth assets, with a small amount held in cash.

What are the risks of investing?

Risk indicator for the Lifestages High Growth Fund:



Average Annual Return

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

31/03/2022

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$207 (that is -2.07% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$326.00 for the year.



Currency hedging

As at 31 March 2023 the fund has an exposure to foreign currency assets of 79.63%, of which 32.99% was hedged back to NZD. This means the fund's foreign currency exposure is 46.64%.
