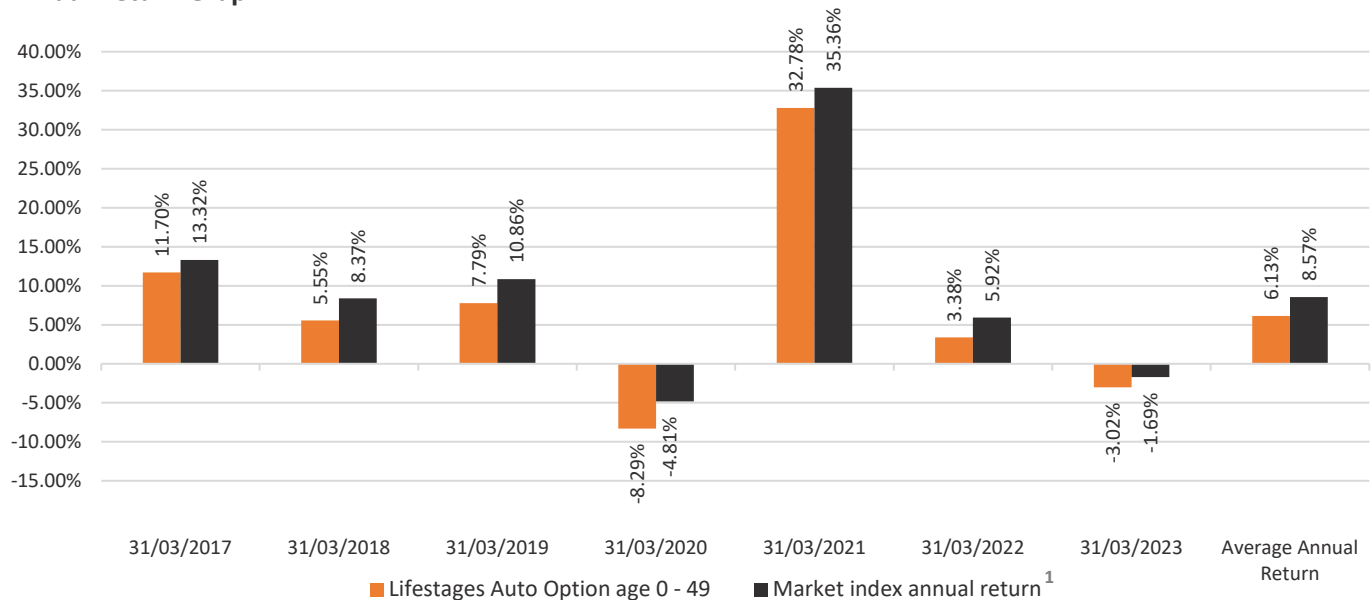


Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 31 March 2023.

Important: This does not tell you how the investment option will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

What fees are investors charged?*

Investors in the Lifestages Auto Option age 0 - 49 are charged fund charges. In the year to 31 March 2022 these were:

** This investment option was not available as at 31 March 2022. Therefore the fee information contained in this document reflects the disclosures that would have applied had the option been in existence as at 31 March 2022. From 1 December 2022, the \$24 annual Member fee was removed. The total fund charges are expected to be 1.15% per annum from 1 December 2022.

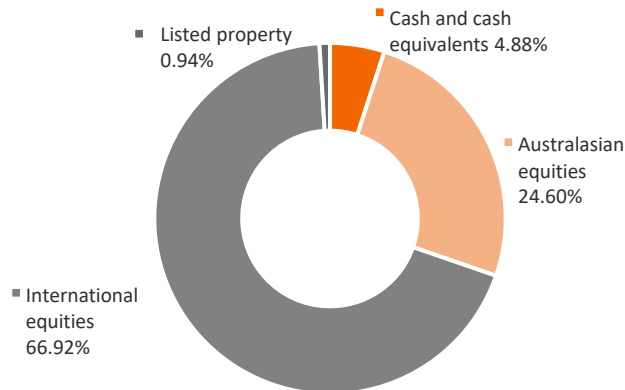
Example of how this applies to an investor

Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$207 (that is -2.07% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$326.00 for the year.

Currency hedging

As at 31 March 2023 the investment option has an exposure to foreign currency assets of 79.63%, of which 32.99% was hedged back to NZD. This means the investment option's foreign currency exposure is 46.64%. Notes

- 1 Note that market indices reflect no deduction for charges and tax.
 - 2 This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
 - 3 The investment option invests 100% in the Lifestages High Growth Fund. The actual investment mix, target investment mix, top 10 investments and currency hedging all reflect the assets invested in the Lifestages High Growth Fund.
