What is the purpose of this update?

This document tells you how the SBS Wealth Australasian Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. SBS Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to achieve capital growth and returns over the longterm through investing primarily in a portfolio of Australasian equities, either directly or indirectly via an underlying fund diversified across various sectors.

What are the risks of investing?

Risk indicator for the SBS Wealth Australasian Equity Portfolio:



Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$1,109 (that is 11.09% of her initial \$10,000). This gives Hayley a total return after tax of \$1,037.00 for the year.

As at 30 September 2024 the fund has an exposure to foreign currency assets of 37.52%, of which 0.00% was hedged back to NZD. This means the fund's foreign currency exposure is 37.52%.
